Tunnel Top Park [San Francisco, CA](#)

For the past year Groundworks Office has been working with a hardy group of neighbors and park stewards to turn this challenging remnant site into a new urban gathering node. With commanding views to the south, the half-acre park is chock-full of site constraints and limitations; location atop a rail tunnel and its proximity to Interstate 280. The response has been to keep the design simple and without any load bearing structures, and focused on mitigating both noise and expanding the ecological relevance of the site. The focal point of the new park is a flexible paved area that will provide a much-needed space for play in the neighborhood. Site storm-water is being focused into a wetland garden that will host a number of aquatic plants and with any hope a frog. A new site-planting regime will be installed that supports local native and drought tolerant plants. A special focus has been placed on plants with a high ecological value that will foster and attract at risk species of both insects and small birds.

Wave Forms Plaza Philadelphia, PA

An open air plaza adjacent to the University of Pennsylvania campus, granite patterned wave forms and planting beds flow and collide at the base of nine large aluminum bell sculptures. Visitors interact with the sculpture, walking in, around and through the pieces. The project was a collaboration with Dennis Oppenheim, who created a series of large bells as the public art component to the project. "By taking the visual configuration found in sound waves to structure the plaza garden, I could detour from the more obvious associations brought forth by the Liberty Bell, Philadelphia's most famous image. By increasing the scale of the bells to approximate architecture, I was able to disturb the association of the bell as 'object' to bell as 'dwelling' " said Oppenheim.

Perched at the edge of the Pacific Ocean a devout team of neighborhood leaders has been working with Groundworks Office to reimagine this vibrant neighborhood node. Taking a long-range approach Groundworks Office has used several community meetings and input from business owners to restructure the intersection and re-configure the demands of transit. The vision proposes a modern transit stop, and two new public plazas that can host neighborhood events. An iconic gateway is proposed with a new transit station that marks the burgeoning neighborhood, as well as provides a safe and proper boarding location for all transit users. Lastly, traffic lanes are reduced to maximize pedestrian comfort, including the expansion of the traffic island to connect the existing gardens into one seamless public space.

Albany Loop Albany, CA


Our proposal, Albany Loop, is a fun and interactive element, visually exuberant and spatially dynamic. Looping across the site, a 12" diameter, high strength steel pipe, re-shapes the homogenous tract of green lawn, into a fun and playful space. At its crescendo, it loops to spell A – L – B – A – N – Y, in an audaciously graphical and energetic statement. The size and scale of Albany Loop have been thoughtfully considered, and intended to be a strong visual landmark, for not only those riding, walking, or scooting along the greenway, but for those passing above. "HEY, THIS IS ALBANY!". The remaining parts of Albany Loop twist and bend to create flexible and fun spots to sit, relax, jump and rest.

Working in collaboration with Widgery Studio, Groundworks Office is developing a proposal for an art installation in a very unique urban space beneath the Powell Street Bridge in Emeryville. Our proposal "DAZZLE" references the distinct geometric patterns painted on ships during WWI and II, to camouflage their distance, speed, and direction on the water. We have adapted this camouflage technique to mask the ominous presence of the Powell Street Bridge and begin the process of creating a vibrant urban node that links north and south, east and west.

By painting the massive columns with a strong geometric pattern they become visually interesting, yet simultaneously dematerialized, and no longer perceived as ugly support columns. Our proposal also relies on rows of stainless steel "leaves" that are mounted to the columns and respond to atmospheric conditions. The "leaves" animate the space in surprising and unpredictable ways. As the "leaves" move and respond to wind conditions, light will bounce around the space, as well, the "leaves" will produce a subtle harmonic sound as they clink against the steel columns.

Pacific Overlook [San Pedro, CA](#)

Pacific Overlook Park is a project that serves the local community's desire for a flexible open space that can be used for a variety of activities, from neighborhood events to Shakespeare in the Park. The materials and design vocabulary reflect the industrial history of San Pedro and the popular Sunken City ruins, created by the collapse of a road on the coast, leaving undeveloped space at the water's edge.

The project successfully addresses site issues associated with shoreline stability and geotechnical requirements. Working closely with the project geotechnical and civil engineers, a unique design solution that prevents infiltration by capping the site while providing for planting areas, parking, and community gathering spaces. The wooden viewing platforms and cor-ten steel planters that rest on top of the concrete pads provide a wide range of seating and gathering spaces oriented to the expansive views of the ocean.

Better Market Street *San Francisco, CA*

With the planned re-paving of Market Street, the City of San Francisco looked at this as an opportunity to re-imagine San Francisco's most iconic street. Traversing through a number of distinct districts along its length, Market Street serves as the transit workhorse for moving people in and around the city. The goal for this project is to envision Market Street as a complete street, a street that serves all users and makes travel safe and enjoyable for pedestrians, bicycles and transit users. Also primary in this effort of re-planning Market Street, is an improvement in the quality and type of public realm along its length. Currently, the street suffers from years of street infrastructure and furniture accrual, and lacks a cohesive vision. The proposed plan seeks to unify the street and allow for district identities to heighten the experience and affect the public realm in positive ways.

Battery Overlook - East [San Francisco, CA](#)

Perched above San Francisco Bay with commanding views to the Golden Gate Bridge, the Battery East Overlook provides a perfect resting spot for pedestrian and cyclist exploring the Golden Gate National Recreation Area. The new plaza and cycle track gently blends with the existing topography and provides a clear circulation paths for both pedestrian and cyclists in this heavy congested approach to the Golden Gate Bridge.

The design of the stadium seating references the massive concrete bunkers that dot the hillsides of the Presidio. The seating area provides a perfect place to gather for interpretive trail walks and informal lectures by tour guides and park stewards. Other features of the Overlook include; interpretive signage, trail maps and an updated parking area.
